SENIOR CITIZEN SOLID WASTE LOW VOLUME RATE PROGRAM DEFINITION

1. The applicant must be 62 years of age or older and must reside at the service address.
(Verification of identity may be a California driver's license or State of California Identification Card.)
2. The account must be in the applicants name.
3. The applicant must produce no more than 64-gallons of garbage per week.

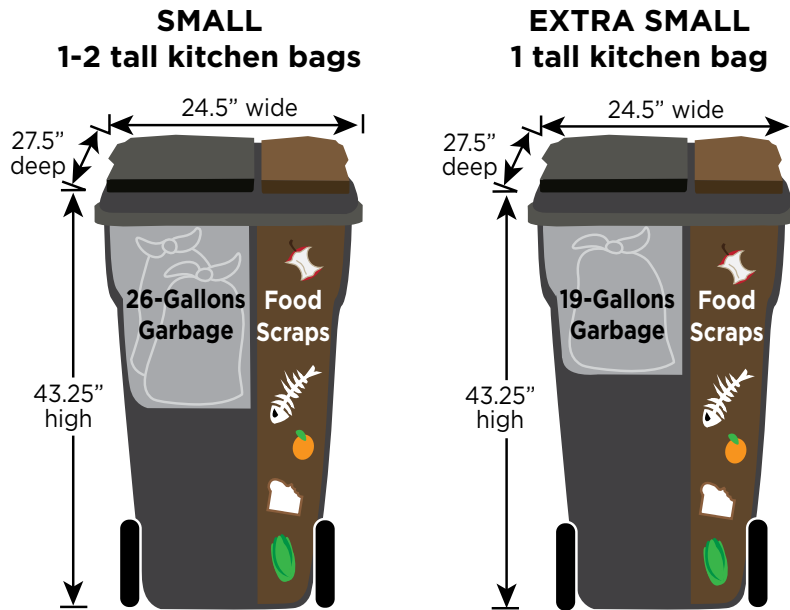

Milpitas Sanitation reserves the right to require those subscribers holding senior citizen status/on-premise collection to provide verification of eligibility upon request. It is the responsibility of the subscriber holding senior citizen status/on-premise collection to notify Milpitas Sanitation of any status change.
