**On-Call Bulky Item
Clean Up Program**

Clean Up is in the Bag!

Single-family residential customers are entitled to four bulky item/clean ups per a rolling 12-month period (scheduled no less than eight weeks apart). Extra bulky item/clean ups can be arranged for a fee.

1 GET THE BAGS.

Call or email Milpitas Sanitation to arrange your bulky item/clean up service. We will deliver two 1.5-cubic yard bags to your residence.



2 PREPARE THE BAG.

Open the bags in the street curbside. THE BAGS MUST BE AT CURB FOR COLLECTION. (When full, they may be too heavy to move.)



3 FILL THE BAGS. Fill your bags curbside twenty-four (24) hours before your scheduled pick up day. Commonly disposed of items include: bulky items (less than 75-pounds each), housewares, packaging materials (styrofoam blocks, large boxes), non-recyclable glass, paper and plastics, small rugs & mats, shoes, clothing, & toys (that cannot be donated), construction and demolition debris (excluding concrete, dirt, brick and rock). **ALL ITEMS MUST FIT WITHIN THE BAGS AND NOT PROTRUDE.**



Out of the Bags...

BULKY ITEMS: Instead of using the bags, a large/bulky item may be set out for collection. Acceptable items include: mattresses, box springs, furniture, appliances, exercise equipment, single tires and more. Refrigerator or freezer doors must be removed or taped shut. Electronic waste such as a computer, printer, television, large microwave and similar items can be set out for collection instead of a large/bulky item.



SMALL E-WASTE: Place in a discardable box or bag before setting next to the clean up bags.



HOUSEHOLD BATTERIES: Place alkaline and lithium batteries in a clear, zipper-lock style bag next to the bags but not in the gutter. Please tape terminals on all lithium, 6-volt and 9-volt alkaline batteries.



Please Note...

SCRAP METAL: Items (less than 30lbs.) can also be placed in the recyclable container side of your Blue **Recyclables** split cart.



YARD TRIMMINGS: Grass clippings, leaves and tree stumps less than 16" in diameter and length can also go in your Green **Yard Trimmings** cart.



Not Allowed in the Bags...

The following items will **NOT** be collected as part of your bulky item/clean up service:

- Loose materials placed outside the bags.
- Any item over 75 pounds (placed in the bags).
- Wood longer than three feet in length.
- Wood treated with chemical preservatives.
- Automobile parts.
- Dirt, sod, cement, rock and brick.
- Hazardous waste (see below).



HAZARDOUS WASTE HAS ITS PLACE.

Hazardous waste does not belong in any Milpitas Sanitation cart or bin. Hazardous items like pesticides, fertilizers, pool & photo chemicals, paint/varnish, toxic cleaning products, smoke detectors, mercury-containing items (thermometers, CFLs/fluorescent lights, etc.), wood treated with a chemical preservative, unwanted medications, and sharps (needles, lancets, etc.) need to be taken to a hazardous waste collection facility. Please Remember!

- The bags must be at the curb by 6:00 a.m. on your scheduled collection day.
- Both bags will be collected at the same time.
- Instead of bags, one large/bulky item may be set out at the curb.
- Do not place bags near obstructions and move vehicles away from the bags for collection access.
