TO THROW GARBAGE.

FOOD SCRAPS & YARD

TRIMMINGS DO NOT belong in

the blue **RECYCLABLES** collection containers. For posters, guides, lists of what belongs in each collection container, and more, please visit: www.milpitassanitation.com/ multifamily/resources/.



Empty, wipe and/or rinse recyclable plastic, metal, and glass food containers. Make sure recyclable paper is clean and dry before placing in the proper **RECYCLABLES** containers.

3. KEEP IT LOOSE! Keep recyclables loose inside your collection container. **Recyclables in bags** (especially opaque/black ones) are sorted out as garbage and end up in the landfill.

Sorting Tip! Keep an Eye on Size!

Corrugated cardboard and paper boxes should be flattened and large pieces cut to 2' x 2' or smaller. Why?

- Allows for more room in your cart or bin.
- Prevents litter and container overflow issues.
- Assures the pieces will fit in the hoppers of our trucks for safe and efficient collection fo recyclables.

Split-Cart Recycling **Means Less Contamination**

Using the Blue **RECYCLABLES** Split Carts or Dedicated Carts and/or Bins properly means:

- Compliance with the City of Milpitas collection program and State Regulations AB341, AB1826, and SB1383.
- Less contamination/ higher quality product to help meet export requirements (see "Did You Know?" below).

DID YOU KNOW?

The majority of your recycling is taken abroad. In 2017, a series of worldwide restricted export requirements for recyclable materials were put in place. These higher standards have:

- Increased the effort (time and labor) required to properly separate and prepare materials for market.
- Decreased the number and types of items that can be recycled.
- Lowered or eliminated recyclable commodity revenues for many materials.

California Regulations Require Recycling and Composting.

California Senate Bill 1383 requires all Multi-Family Residences, regardless of complex size, to sort RECYCLABLES & ORGANIC material (including food scraps and food-soiled paper) out of the garbage. Visit: www.calrecycle.ca.gov/organics/slcp for more info.

Kitchen Food Scraps Pails:* Used to store food scraps until emptied as needed into the food scraps collection containers.

Thank you for taking these simple steps to help us provide safe and efficient services for you.

- Properly sort your discarded materials.
- Make sure your container lids close to prevent overflow and litter.
- Bag waste and place in the gray GARBAGE containers. (Remember: gloves, masks, wipes, tissues, and anything with bodily fluids should be bagged and placed in the garbage.)
