

Is Your Business Compliant with <u>Required</u> State Recycling Regulations?



• California regulations AB341, AB1826, and SB1383 require recycling. Commercial businesses MUST SORT RECYCLABLES, FOOD SCRAPS, and ORGANIC MATERIAL OUT OF THE GARBAGE. Visit our website or www.CalRecycle. ca.gov for information about the Mandatory Commercial Recycling Legislation.

• **AB 827** - Businesses that sell food and drinks and have onsite dining must provide recycling & organics collection containers inside their business for customers. For additional info about the law, signage, flyers, & more, visit: www.calrecycle.ca.gov/Recycle/Commercial/Organics/PRToolkit/

• **AB 1276** - Reduces trash pollution by requiring businesses to only provide single-use food utensils and condiment packets when customers specifically ask for them. For additional info, visit: https://leginfo.legislature.ca.gov

PLEASE REMEMBER: items such as Styrofoam® blocks, sheets and peanuts, film plastics such as shrink wrap and bubble wrap, online retailer shipping bags, and wood pallets <u>do not belong</u> in the recycling stream.
